LIQUOR LICENSE	\$1,859	Liability insurance including: \$100,000 ea.person/\$300,000 more than one person/\$50,000 due to injury or destruction of property ea.occurrence/\$50,000 for loss of means of support of any one person in ea.occurrence & \$100,000 for loss of means of support of two or more persons ea.occurrence. Policy coverage dates to coincide with licensing period & ten days prior cancellation notice must be given to City of B.E.
CLUB LICENSE	\$128	Liability insurance including: \$100,000 ea.person/\$300,000 more than one person/\$50,000 due to injury or destruction of property ea.occurrence/\$50,000 for loss of means of support of any one person in ea.occurrence & \$100,000 for loss of means of support of two or more persons ea.occurrence. Policy coverage dates to coincide with licensing period & ten days prior cancellation notice must be given to City of B.E.
WINE LICENSE	\$200	Liability insurance including: \$100,000 ea.person/\$300,000 more than one person/\$50,000 due to injury or destruction of property ea.occurrence/\$50,000 for loss of means of support of any one person in ea.occurrence & \$100,000 for loss of means of support of two or more persons ea.occurrence. Policy coverage dates to coincide with licensing period & ten days prior cancellation notice must be given to City of B.E.
3.2 BEER LICENSE	\$125	Liability insurance including: \$100,000 ea.person/\$300,000 more than one person/\$50,000 due to injury or destruction of property ea.occurrence/\$50,000 for loss of means of support of any one person in ea.occurrence & \$100,000 for loss of means of support of two or more persons ea.occurrence. Policy coverage dates to coincide with licensing period & ten days prior cancellation notice must be given to City of B.E.
TEMPORARY ON-SALE LIQUOR	\$36	Liability insurance including: \$100,000 ea.person/\$300,000 more than one person/\$50,000 due to injury or destruction of property ea.occurrence/\$50,000 for loss of means of support of any one person in ea.occurrence & \$100,000 for loss of means of support of two or more persons ea.occurrence. Policy coverage dates to coincide with licensing period & ten days prior cancellation notice must be given to City of B.E.
SUNDAY LIQUOR LICENSE	\$200	Liability insurance including: \$100,000 ea.person/\$300,000 more than one person/\$50,000 due to injury or destruction of property ea.occurrence/\$50,000 for loss of means of support of any one person in ea.occurrence & \$100,000 for loss of means of support of two or more persons ea.occurrence. Policy coverage dates to coincide with licensing period & ten days prior cancellation notice must be given to City of B.E. Must hold a current liquor license in the City of Blue Earth.

<i>TYPE OF LICENSE</i>	<i>ELIGIBILITY TO BE LICENESED BY THE CITY OF B.E/STATE OF MN</i>
LIQUOR LICENSE	Must be age 21 years or older. No prior licensing violations or felony convictions (within last 5 years). No direct or indirect interest in a liquor manufacturer, brewer or wholesaler. Must be of good moral character.
CLUB LICENSE	Must be age 21 years or older. No prior licensing violations or felony convictions (within last 5 years). No direct or indirect interest in a liquor manufacturer, brewer or wholesaler. Must be of good moral character.
WINE LICENSE	Must be age 21 years or older. No prior licensing violations or felony convictions (within last 5 years). No direct or indirect interest in a liquor manufacturer, brewer or wholesaler. Must be of good moral character.
3.2 BEER LICENSE	Must be age 21 years or older. No prior licensing violations or felony convictions (within last 5 years). No direct or indirect interest in a liquor manufacturer, brewer or wholesaler. Must be of good moral character.
TEMPORARY ON-SALE LIQUOR	A club, charitable, religious, or other nonprofit organization in existence at least 3 yrs. The license may authorize on-sale intoxicating liquor for not more than 4 consecutive days in connection with a social event sponsored by the licensee.
SUNDAY LIQUOR LICENSE	Must be age 21 years or older. No prior licensing violations or felony convictions (within last 5 years). No direct or indirect interest in a liquor manufacturer, brewer or wholesaler. Must be of good moral character. Must hold a current liquor license in the City of Blue Earth.

<i>TYPE OF LICENSE</i>	<i>ON SALE FACILITY REQUIREMENTS AND HOURS OF SALES</i>
LIQUOR LICENSE	A hotel with a public dining room containing seating capacity of at least 30 people or a restaurant containing seating capacity of at least 100 people. Full food service during all business hours. Off-street parking on or adjacent to licensed premises with one parking space for each 3 customers. No liquor sold after 1:00 A.M. on Sunday until 8:00 A.M. on Monday nor sales made between the hours of 1:00 a.m. and 8:00 A..M. on any weekday.
CLUB LICENSE	A facility adequate and suitable to accommodate the organization's club members. The term "club" is defined under chapter 4, section 400.01, subd.5 of the City Code. No liquor sold after 1:00 A.M. on Sunday until 8:00 A.M. on Monday nor sales made between the hours of 1:00 a.m. and 8:00 A..M. on any weekday.
WINE LICENSE	A hotel with a public dining room containing seating capacity of at least 30 people or a restaurant containing seating capacity of at least 100 people. Full food service during all business hours. Off-street parking on or adjacent to licensed premises with one parking space for each 3 customers. No wine sold after 1:00 A.M. until 10:00 A.M. Sunday through Friday.
3.2 BEER LICENSE	A hotel with a public dining room containing seating capacity of at least 30 people or a restaurant containing seating capacity of at least 100 people. Full food service during all business hours. Off-street parking on or adjacent to licensed premises with one parking space for each 3 customers. No beer sold between 1:00 A.M. and 8:00 A.M. Monday through Saturday or Sunday from 1:00 A.M. and 12:00 Noon.
TEMPORARY LIQUOR LICENSE	The facility selected to be used for this license must first be approved by the commissioner of public safety. No liquor sold after 1:00 A.M. on Sunday until 8:00 A.M. on Monday nor sales made between the hours of 1:00 A.M. and 8:00 A.M. on any weekday.
SUNDAY LIQUOR LICENSE	A hotel with a public dining room containing seating capacity of at least 30 people or a restaurant containing seating capacity of at least 100 people. Full food service during all business hours. Off-street parking on or adjacent to licensed premises with one parking space for each 3 customers. No beer sold between 1:00 A.M. and 8:00 A.M. Monday through Saturday or Sunday from 1:00 A.M. and 12:00 Noon. Must hold a current liquor license in the City of Blue Earth.
