**CITY OF BLUE EARTH
SANITARY AND STORM SEWER PERMIT REQUIREMENTS**

CONTRACTORS **MUST** FILL OUT THE PERMIT APPLICATION

The following information must accompany each permit for each new construction and is required for all connections to the City Sanitary and Storm Sewer. If your work involves any of the following you are REQUIRED to call for an inspection.

1. Installation or repair of Sanitary or Storm Sewer
2. Disconnect from Sanitary or Storm Sewer
3. Repair to Sanitary Sewer Service Line
4. Replacement of Sanitary Sewer Service Line
5. Footing Drain repair or installation of Footing Drains
6. Roof Drain connections *if applicable*
7. Sump Pump installation or re-plumbing of existing Sump Pump
8. Any type of sewer work or repair that would result in discharging water or wastewater from any source to the City Sanitary Sewer or Storm Sewer Collection System

DO NOT BACK FILL UNTIL INSPECTION IS COMPLETED! If underground work is back filled or covered before inspection, the permit holder and or contractor are responsible and are subject to the expense of removing the fill or cover for inspection. If the contractor is not the permit holder, this information must be passed on to the contractor or responsible party doing the work.

Pipe, connections, and tracer wire must be visible for inspection!

If working in City Right of Way, heavy equipment must not drive over curbs without proper bridging. The contractor is responsible for restoration cost.

All newly installed sewer service lines from building to street must be pressure tested and pass the plumbing code required 5lb. for 15-minute air test and must be inspected.
